PETITIONERS' RULE 26.1 DISCLOSURE

Pursuant to Circuit Rule 26.1 of the United States Circuit Court of Appeals for the District of Columbia Circuit, Petitioners make the following disclosures:
Beyond Nuclear, Inc.: Beyond Nuclear has no parent companies, and there are no publicly held companies that have a 10 percent or greater ownership interest in Beyond Nuclear.

Beyond Nuclear is a national watchdog organization on the nuclear power and radioactive waste industries, as well as on the federal government agencies which are supposed to protect the public and the environment from the risks of radiation and radioactive waste to human health and ecosystems. Beyond Nuclear aims to educate and activate the public about the connections between nuclear power and nuclear weapons and the need to abandon both to safeguard our future, including on the risks associated with the inevitable generation of radioactive waste by the nuclear industry. Beyond Nuclear advocates for an energy future that is sustainable, benign, and democratic. It is headquartered in Takoma Park, Maryland, a Nuclear-Free Zone.

Blue Ridge Environmental Defense League, Inc. (BREDL): BREDL has no parent companies, and there are no publicly held companies that have a 10 percent or greater ownership interest in BREDL.

BREDL is a 25-year-old regional, community-based non-profit environmental organization in the southeastern United States, whose founding principles are earth stewardship, environmental democracy, social justice, and community empowerment. BREDL encourages government agencies and citizens to take responsibility for conserving and protecting our natural resources. BREDL advocates grassroots involvement to empower whole communities in

environmental issues. BREDL also functions as a “watchdog” of the environment, monitoring issues and holding government officials accountable for their actions.

Missouri Coalition for the Environment, Inc. (Missouri Coalition): Missouri Coalition has no parent companies, and there are no publicly held companies that have a 10 percent or greater ownership interest in Missouri Coalition.

Missouri Coalition is an environmental advocacy organization, working on a variety of issues that affect human and environmental health. Missouri Coalition focuses on issues surrounding clean water, clean air, clean energy, and a healthy environment and uses education, public engagement, and legal action to achieve its goals.

New England Coalition, Inc.: New England Coalition has no parent companies, and there are no publicly held companies that have a 10 percent or greater ownership interest in New England Coalition.

New England Coalition has advocated for safe energy in New England and has provided education and resources for alternatives to nuclear power. New England Coalition has also intervened in numerous Nuclear Regulatory Commission (NRC) licensing proceedings involving the safety and environmental impacts of spent fuel storage at New England nuclear power plants.

Nuclear Information and Resource Services, Inc. (NIRS): NIRS has no parent companies, and there are no publicly held companies that have a 10 percent or greater ownership interest in NIRS.

NIRS is a non-profit corporation with over 12,000 members across the United States. NIRS has a mission to promote a nonnuclear energy policy and a concern for the health and safety of the people and ecosphere.

Riverkeeper, Inc.: Riverkeeper has no parent companies, and there are no publicly held companies that have a 10 percent or greater ownership interest in Riverkeeper.

Riverkeeper is a non-profit, membership-supported environmental organization. Its mission is to protect the environmental, recreational, and commercial integrity of the Hudson River and its tributaries, and safeguard the drinking water of nine million New York City and Hudson Valley residents.

San Luis Obispo Mothers for Peace, Inc. (SLOMFP): SLOMFP has no parent companies, and there are no publicly held companies that have a 10 percent or greater ownership interest in SLOMFP.

SLOMFP is a non-profit organization concerned with the risks and hazards connected with the Diablo Canyon Nuclear Power Plant and with the dangers of nuclear power, weapons, and waste on national and global levels. An all-volunteer

non-profit group, SLOMFP has challenged NRC licensing decisions within the NRC and in Federal Courts since 1973.

Southern Alliance for Clean Energy, Inc. (SACE): SACE has no parent companies, and there are no publicly held companies that have a 10 percent or greater ownership interest in SACE.

SACE is a coalition of environmental and citizen organizations promoting green energy in the southeastern United States. SACE has intervened in several NRC proceedings for the licensing of new nuclear power plants.

Sustainable Energy and Economic Development Coalition, Inc. (SEED Coalition): SEED Coalition has no parent companies, and there are no publicly held companies that have a 10 percent or greater ownership interest in SEED Coalition.

SEED Coalition is a legal DBA under the Texas Fund for Energy and Environmental Education, Inc., a statewide nonprofit organization with 2,500 members working for clean air and clean energy in Texas. The organization advocates for sustainable energy, including energy efficiency, renewable energy, and conservation.
