ORDER

(Terminating the Adjudicatory Proceeding)

On August 30, 2012, the Board granted Summary Disposition in favor of Intervenors on Contention 1, holding that Applicants are ineligible to obtain a license because they fail to meet the requirements of Section 103(d) of the Atomic Energy Act, 42 U.S.C. § 2133(d), and 10 C.F.R. § 50.38.<sup>1</sup> The Board's August 30 Order further stated that the proceeding would be terminated 60 days after the issuance of the Order unless, within that time, Applicants provided information to show that they have changed their ownership situation so as to satisfy foreign ownership, control, and domination requirements.<sup>2</sup> Because no such information has been submitted to the Board and the sixty day period has expired, this proceeding is hereby terminated.
