SUBJECT: Request for Postponement of Vote on Final Rule re: Continued Storage of Spent Nuclear Fuel Pending Resignation of Commissioner Magwood

Dear Commissioners:

On behalf of 34 environmental organizations and individuals, we are writing to request you to postpone, until after Commissioner Magwood's August 31 departure from the U.S. Nuclear Regulatory Commission ("NRC"), your tentatively scheduled August 26 Affirmation Session, in which you plan to address two extremely important safety and environmental matters: whether to adopt the draft Final Rule regarding Continued Storage of Spent Nuclear Fuel and whether to lift the stay of reactor licensing that you imposed in 2013, pending completion of your response to the U.S. Court of Appeals' decision in *New York v. NRC*, 681 F.3d 471 (D.C. Cir. 2012).

By postponing the Affirmation Session into early September, you will not delay the issuance of a Final Rule, which is not scheduled until October 3, 2014. You will, however, alleviate the taint on the integrity of the NRC's decision-making process created by Mr. Magwood's continued participation in NRC safety and environmental decisions. As discussed in our previous correspondence, Mr. Magwood has created a real and apparent conflict of interest by pursuing and accepting a position with an international agency whose primary purpose is to promote nuclear power, at the same time he serves on a U.S. agency that is dedicated to protection of

public health and safety and the environment.³ If Mr. Magwood is permitted to participate in the upcoming vote, state and local governments and members of the public – who must live with the effects of the NRC's decisions – will have legitimate grounds to question whether Mr. Magwood unduly influenced the agency to gloss over the serious problems that attend the long-term storage and disposal of spent reactor fuel, in order to fulfill his new mission of promoting nuclear energy worldwide.

Despite his glaring conflict of interest, Mr. Magwood has refused our request that he recuse himself from NRC decisions relating to safety and protection of the environment.⁴ Therefore it falls to you, the other members of the Commission, to protect the integrity and credibility of your decision-making process by postponing this very important affirmation session until after Mr. Magwood's departure. Accordingly, we request you to postpone your affirmation session until after Mr. Magwood has left the agency.
